" I hereby agree to abide by the policies established in the La Costa 35 ATHLETIC CLUB (LC 35 AC) regarding the use of bats during all softball games (practice games, regular season games, All Star games, State competition games, Home Run derby competitions) played under all divisions of softball in the LC 35 AC.

By signing this application, I understand and I agree with the prohibitions disallowing me to bring into the dugout or to knowingly use during any LC 35 AC softball event, including batting practice, an "altered" bat, or any non-ASA approved bat not approved by the LC 35 AC. Currently, the only use of non-ASA approved bats are for players 60 years of age or older

An "altered" bat is any bat where the label has been changed or a bat where the barrel has been modified in any way to enhance performance of the bat by increasing the velocity of a ball coming off the bat.

I understand and I agree that I will forfeit for life , or as otherwise directed by the BOARD, all rights and privileges of further participation in any and all LC 35 AC sports activities for violation of LC 35 AC prohibitions on use of bats and/or other equipment. I understand that I may be held personally liable for any injury sustained by any player(s) resulting from being hit with a ball off an altered bat or non-approved bat that I either bring into the dugout or knowingly use during any LC 35 AC softball event."
